SJIB NATIONAL WORKING RULES AMENDMENT TO THE PROMULGATION NOTICE – SJIB CIRCULAR 04/2023

Following the publication of new statutory minimum rates of pay to come into effect on 1 April 2024, the agreed rates for Stage 1 & Stage 2 Apprentices have been amended to reflect the statutory requirements. The new rates will apply with effect from Monday 1 January 2024.

Further previously agreed enhancements to both rates and some terms of employment will take effect on Monday 6 January 2025 as detailed in the amended Promulgation Notice attached.

The SJIB National Board will review the negotiated contractual rates for Apprentices towards the end of this year when the UK Government publishes the National Minimum Wage Rates and National Living Wage for 2025.

SJIB NATIONAL WORKING RULES WAGES AND CONDITIONS FOR 2024 & 2025 AMENDED PROMULGATION NOTICE (26 JANUARY 2024)

1. Two-Year Agreement

A two-year agreement has been reached with implementation dates on:

Year 1 1 January 2024 Year 2 6 January 2025

2. Wages - SJIB National Working Rules - Section B, Rule 1.2

The rates of pay are to be increased by the following percentages:

Monday 1 January 2024 7% Monday 6 January 2025 5%

The Approved Electrician rate will be: -

3. Lodging Allowance – SJIB National Working Rules – Section B, Rule B31 and Appendix B1

Lodging Allowance increases are based upon a formula which tracks the movement in the catering element of the Consumer Price Index and are subject to approval by HMRC. The rates effective from **Monday 1 January 2024** will be advised separately later this year.

4. Weekly Sick Pay in addition to SSP for Operatives and Adult Trainees – SJIB National Working Rules – Section E, Rule E5.1 and Appendix B1

With effect from **Monday 1 January 2024**, weekly sick pay in addition to SSP will increase as follows:

In addition, with effect from **Monday 6 January 2025**, after eight weeks of continuous sickness absence, payment of waiting days 8-14 (i.e., the second week of the sickness absence claim) will be made retrospectively. There will be no payment for days 1-7 (i.e., the first week).





5. Death Benefit - SJIB National Working Rules - Section E, Rule E5.2 and Appendix B1

With effect from **Monday 6 January 2025**, the Death Benefit for Operatives and Adult Trainees will increase to £40,000.

6. Approved Electrician Responsibility Money – SJIB National Working Rules – Section B, Rule B 23 and Appendix B1

With effect from **Monday 6 January 2025**, Responsibility Money for Approved Electricians will be from 50p to £2.

- 7. In addition to the wages and conditions agreement outlined above, the Employers and the Union have agreed to:
- review the level of remuneration payable to electrical installation apprentices and the position of electrical contracting wage levels.
- include wording in the handbooks to outline the current statutory pension arrangement and to amend the current wording in Section 4, clause 6 of the JIB Handbook to reflect a broader range of training courses.

This agreement is a complete package and is indivisible and is in full and final settlement of all wages and conditions claims over the period Monday 1 January 2024 to Sunday 4 January 2026 inclusive.
